4a (Code:) (Expenses \$ 764,954. including grants of \$) (Revenue \$ 809,303.) Education services - programs are provided for children who are experiencing visual difficulties and/or blindness. Specialized instruction in disability-specific compensatory skills and adaptive techniques provided by a teacher of the visually impaired. Programs include orientation and mobility instruction, personal management and alternative communication skills. The organization provided service to 147 children in the school and community throughout New Hampshire including students in 46 districts during the 2017/2018 school year. Each student has an individual education plan which sets specific goals and outcomes.

4b (Code:) (Expenses \$ 203,533. including grants of \$) (Revenue \$ 836.) Social work - the social work program includes individual and family adjustment to vision loss counseling, support groups and referrals to community services. The average number of clients receiving intake, case management and referral monthly is 36 (432 unique total clients for the year). The number of clients/family members offered adjustment to blindness counseling was 8 over the past year. The number of clients in peer support groups is 57.

4c (Code:) (Expenses \$ 107,037. including grants of \$) (Revenue \$ 24,542.) Occupational therapy - occupational therapy's focus is to assist people to achieve their highest level of independence, enabling them to participate in activities of daily living despite their vision loss.
