Youth services - programs are provided for children who are experiencing visual difficulties and/or blindness. Specialized instruction in disability-specific compensatory skills and adaptive techniques provided by a teacher of the visually impaired. Programs include orientation and mobility instruction, personal management and alternative communication skills. The organization provided services to 97 children in the school and community throughout New Hampshire including students in 33 districts during the 2023/2024 school year. Each student has an individual education plan which sets specific goals and outcomes.

Adult services - Our team of professionals deliver a full range of specialized vision services to enhance independence by creating individualized, person-centered plans to meet each person's unique needs whether they are working adults, active older adults, or those seeking to sustain their level of independence, safety, and comfort as they age. We utilize a holistic approach to supporting the whole person through an array of services that includes Client Care Coordination, Occupational Therapy, Low Vision Services, Rehabilitation Services, Social Work Counseling, Orientation & Mobility Services, and Assistive Technology. The organization provided services to a total of 846 adults in the fiscal year.
